Just a short note to let you know that I graded the written portion of your test today and was truly impressed. I gave it 91 points out of a possible 100: an outstanding job. You know more about beer and brewing than most of the people in the program, believe me.

I did not try to evaluate the score sheets, because Pat Baker gave me no guidelines on how to do this. I will say that your most serious problem was the score you gave that first beer, which was clearly defective. However, I would argue (and have pleaded to Pat) that you must have been influenced by your knowledge of who the brewer was, and also the fact that that nasty mutant-yeast type of phenolic off flavor takes experience to identify.

I had no hesitation about recommending you for a "high pass" and admission into the program. Of course, your official score will be up to Pat, but I think you can stop worrying. I am sure you will be admitted at whatever level he decides your experience entitles you to.

Good luck in all your brewing and judging activities. I hope to see you again at the next HA conference in Dallas, if not sooner.
